TO: The Vancouver Organizing Committee for the 2010 Olympic and Paralympic Winter Games, Lost Lake Cross Country Connection Corporation, Callaghan Country Wilderness Adventures Ltd., Resort Municipality of Whistler and their directors, officers, employees, guides, instructors, agents, representatives, volunteers, independent contractors, sub-contractors, sponsors, successors and assigns (hereinafter collectively referred to as the "Releasees").

**RENTAL AGREEMENT**

- I accept full responsibility for the care of the rental equipment ("the Equipment") listed on this form and I agree to pay for any damage to the Equipment and to replace at full retail value any Equipment not returned by the agreed date.
- I am familiar with the proper use of the Equipment. I understand that the rental technicians are able to answer any questions I may have as to the proper use of the Equipment.

**DEFINITIONS**

In this Release Agreement the term "**Activities**" shall include cross-country skiing, telemark skiing, snowshoeing, ski jump tours, biathlon, and all other recreational or sports activities and tours that take place at the Whistler Olympic Park.

**ASSUMPTION OF RISKS**

I am aware that participating in the Activities involves various risks, dangers and hazards and that injuries are a common and ordinary occurrence of these sports. These risks, dangers and hazards include but are not limited to: collision with natural or man made objects, including rocks, stumps, trees and mechanical snow grooming equipment; collision with other persons; variable and difficult snow conditions; negligence of other persons; and NEGLIGENCE ON THE PART THE RELEASEES including failure on the part of the Releasees to take reasonable steps to safeguard or protect me from the risks, dangers and hazards of the Activities. I am also aware that backcountry travel should not be attempted without specific training and equipment.

I understand that the boot/binding system used for cross-country skiing, telemark skiing and snowshoeing is not designed or intended to release and will not release under normal circumstances. I understand that as the boot / binding system is a non-release system, this system will not reduce the risk of injury during a fall and will increase the risk of not surviving an avalanche.

I FREELY ACCEPT AND FULLY ASSUME ALL RISKS, DANGERS AND HAZARDS ASSOCIATED WITH THE ACTIVITIES AND THE USE OF THE EQUIPMENT.

**RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT**

In consideration of the rental of the Equipment or my participation in the Activities, I hereby agree as follows:

1. I AGREE TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against the Releasees and TO RELEASE THE RELEASEES from any and all liability for any damage, expense or injury including death that I may suffer, or that my next of kin may suffer, resulting from or arising out of any aspect of my use of the Equipment or participation in the Activities, DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT OR BREACH OF STATUTORY DUTY OF CARE, INCLUDING ANY DUTY OWED UNDER THE OCCUPIERS LIABILITY ACT, R.S.B.C. 1996, c.337, in respect of the selection or maintenance of the Equipment or in respect of the provision or failure to provide any warnings, directions or instructions as to the use of the Equipment or the risks, dangers and hazards of the Activities.
